Background

The purpose of this draft policy is to ensure the Council complies with its legal obligations on gas safety in Council-owned residential buildings.

The aim is to encompass clear processes in identifying how SCC carries out its role as a landlord, and how it will take every reasonable step to get access to properties as appropriate according to its responsibilities under the Gas Safety (Installation and Use) Regulations 1998 for gas appliances.

The draft policy would, if implemented:

- > Ensure landlord gas safety checks and services are accessible to all domestic tenants, by working closely with agencies such as social services and the police;
- > Outline a clear process for dealing with no-access properties;
- > Provide clear guidance to all SCC staff and domestic tenants, and;
- > Raise the profile of the programme, the health and safety of tenants, and highlight the risks of not complying with the Council's statutory responsibilities on gas safety.
