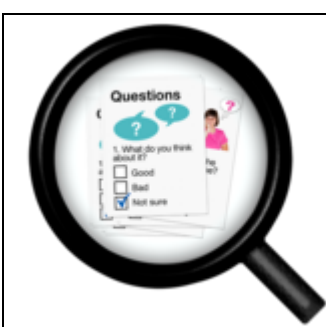

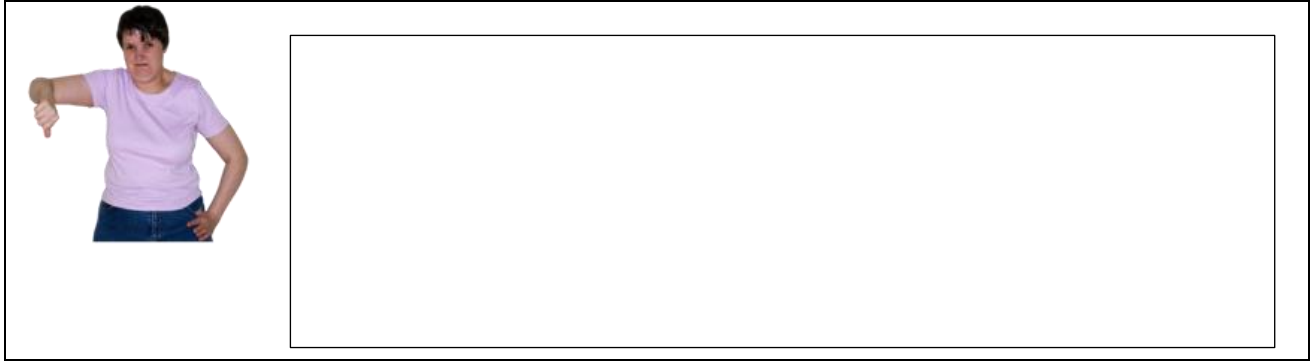

<u>Summary</u>	<p>Southampton City Council would become the provider at Weston Court and run this as well as Kentish Road.</p> <p>More bed spaces would be available at Kentish Road for those who do not have complex needs and might previously have been cared for at Rose Road.</p>	<p>Services at Weston Court would be stopped meaning the majority of overnight residential respite will be at Kentish Road.</p> <p>More bed spaces would be available at Kentish Road for those who do not have complex needs and might previously have been cared for at Rose Road and anyone that may have been cared for at Weston Court.</p>
