A person aggrieved by the proposals who desires to question their validity on the ground that they are not within the powers conferred by Part 11 of the Town and Country Planning Act 1990 or that any requirement of that Act or any regulation made under it has not been complied with in relation to the adoption of the proposals, may, within 6 weeks from 2nd March 2006, make an application to the High Court under Section 287 of the 1990 Act.
