


What is Easy Read?

Southampton City Council is thinking about changing how we help children and young people travel to school.






Travelling to school



We help about 1,700 children and young people travel to school every day.



The law says we must do this free if:





 The child is over 8 years old and lives more than 3 miles from their nearest suitable school



We do not have to give travel support for children in nursery or children who have finished year 11. The law says that we also must do this for free if



 The way of walking to school is not safe to the nearest suitable school



 The child has SEND and needs extra help to travel to school or lives too far away to walk to the nearest suitable school

SEND stands for **S**pecial **E**ducational **N**eeds and **D**isabilities. Children with SEND are aged 0 to 25 and need some extra support to learn and grow



We also help some other children travel to school.

We charge their **parents** some money for this



In this booklet, when we say school, this includes schools, colleges or other education setting.

In this booklet, when we say **parents**, this includes:



• Birth parents, carers or guardians – these are people who the law says can look after a child



 Parents who have adopted a child – this is when a child becomes part of a new family when they cannot be brought up by their own family



• Foster families – these are families who look after children who cannot live with their own parents

The changes we are thinking of making

There are 8 changes we are thinking of making:



1. Make the information about what we offer clearer and easier to understand.



2. Offer some families with a Personal Travel Budget more money.



3. Change travel options for young people aged 16-19 years.



4. Ask young adults what they need to get to their education setting.



5. Stop providing free travel support to children if they move away from their school.



6. How much time we give you when we stop your travel support.



7. Stop travel support to children who are **not** entitled to it but can pay for it.



8. Tell us about your 3 nearest suitable schools on the school application form if you want to ask for travel support.



We will explain more about these changes in the next parts of this booklet.

Change 1 (1 of 2): The School Travel Service Policy



The **School Travel Service Policy** is a set of rules that explain what we need to do to support children and young people to travel to school.

We are thinking of making some changes to it, to make it:



More up to date



• Clearer and easier to understand



These changes would mean that our School Travel Policy fits in with the Government's rules.



There are lots of small changes to the way the rules are written.



These will not change how the rules work. They will just use different words to tell parents about the rules.

Change 1 (2 of 2): The School Travel Service Policy



The **School Travel Service Policy** is a document that explains what we need to do to support children and young people to travel to school.



The policy is for children and young people aged 5 – 25 years old.



But the rules are different for young people aged 16 - 25 years old.



We want to have two policies. One for 5 – 16 years old and one for 16 - 25 years old.



This will make it easier to understand the rules.

Change 2: Personal Travel Budgets



Many of the children and young people that we help travel to school use buses, minibuses or taxis.



Some children and young people need to travel in different ways, like in cars with extra equipment to help them.



But sometimes it is hard for us to provide the right ways of travelling that these children and young people need.



We give some families money to pay for travelling to school so they can choose to find a way of travelling that is right for them.



Some families need even more support because they have other children or young people that need to get to school.



Some families need more support because they need to take time off work to take their child or young person to school.



We want to give these families a bit more money to help them manage to do this.

Change 3 (1 of 2): Travel for Young People Aged 16-19



Many of the children and young people that we help travel to school use buses, minibuses or taxis.

But we do not have to do this by law.



We want to support young people to travel on their own.

This means for some young people we will stop providing transport.



Instead, we would give young people some money to pay to travel to college, so they can choose a way of travelling that is right for them.



If needed, we would train young people to travel from home.



But there may be some young people who can only get to college if we offer a bus, minibus or taxi.



We would like to change the rules so that we can ask some families for money to help pay for the bus, minibus or taxi.


Change 3 (2 of 2): Travel for Young People Aged 16-19



Many of the young people that we help travel to school use buses, minibuses or taxis.



Right now, we do not say how much travel support we give to young people.



We want to be clearer about how much travel support we can give.

If a student does get travel support, they will get up to 18 hours of support over 3 days each week.

This means they can only get travel support for up to 18 hours across the 3 days.

Change 4: Travel for Young Adults with SEND



Many of the children and young people that we help travel to school use buses, minibuses or taxis.



We do this based on what we think the young adult needs.



We want to change this so that the young adult tells us why they need help with their travel.

Change 5: Travel support for children who have moved away from their school



When a family moves house to another area, the council will sometimes pay for the child to travel the same school.



The means the council is having to pay more money when families choose to move house.

The council does not have to provide or pay for this travel support.



We want to change this so that families who move to a house in another area would have to find a way of getting to school every day. This change would include children in years 10 and 11.

Change 6: When we tell you that your travel support is changing



Most of the children and young people that we help travel to school use buses, minibuses or taxis.



There are rules about when we can give you travel support.



If something changes, we may stop travel support for a child or young person.



If we stop helping you with your travel support, we give you notice of one school term.



We want to change this and give you 4 weeks' notice or until the end of the current half-term that the travel support will stop.

Change 7: Families who pay to travel to school



The law says that we must provide free travel for some children and young people to get to and from school.



But sometimes we provide travel to other children or young people that we do not have to by law.



If we do provide travel, we charge them some money.

Right now, no families use this service.



We want to change the rules so that we stop offering a travel service to children who are **not** entitled to it but can pay for it.
