Background

The Licensing Act 2003 (the Act) requires licensing authorities to publish a "statement of licensing policy" every five years. This sets out how they intend to exercise their functions. The policy also describes a general approach to making licensing decisions.

The current Statement of Licensing Policy (SLP) was adopted by the Council in 2020 to run from 2021 until January 2026. Therefore, Southampton City Council are now required to review the overall policy.

Referring to the Cumulative Impact Assessment (CIA) as a separate document

Currently, there is a requirement for the authority to conduct a Cumulative Impact Assessment (CIA) every three years. The purpose of a Cumulative Impact Assessment (CIA) is to help the authority limit the licences that it grants in areas where there is evidence to show that the number or density of licensed premises may be contributing to problems that are undermining licensing objectives.

The Statement of Licensing Policy (SLP) is reviewed every five years, which means the two review periods are out of sync.

At the moment, we include the Cumulative Impact Assessment (CIA) within the Statement of Licensing Policy (SLP), however, due to the review periods being out of sync for the different elements, it makes more sense for them to become two separate documents.

We are therefore proposing to remove the Cumulative Impact Assessment (CIA) from the policy and hold it as a separate document that the Statement of Licensing Policy (SLP) refers to.

The proposal will mean that the Cumulative Impact Assessment (CIA) will hold the details of the stress areas and the evidence to support them.

Promotion of the 'Ask for Angela' scheme

The Statement of Licencing Policy sets out the Authority's expectations in relation to certain matters.

Currently there is no expectation to promote the 'Ask for Angela' scheme. The 'Ask for Angela' scheme is a safety initiative that allows anyone feeling unsafe or vulnerable to discreetly ask for help in bars, clubs, and other venues by asking a staff member for "Angela.

We are proposing that late night venues promote the 'Ask for Angela' scheme and undertake training to support the VAWG safety initiatives in the city and support the introduction of other schemes such Shout up! And White Ribbon.

Adopting the 4 E's approach (Engage, Explain, Encourage and Enforce)

We are proposing to adopt the 4 E's approach within the policy – 'Engage, Explain, Encourage and Enforce'.

Licence holders are ultimately responsible for the management of their business, following the guidance offered by the authority.

The 4 E's create a supportive approach to compliance by council officers identifying issues, engaging and explaining the issues to licence holders and encouraging them to become compliant. This approach outlines using enforcement as a last resort or in cases of serious breaches.

Enforcement applies once there has been failure to effectively address or respond to problems or isolated serious failures. As a result, the application is reviewed.

However, the 4 E's approach does not prevent council officers using the enforcement option at the outset when circumstances are serious enough to merit such an approach.
