SOUTHAMPTON CITY COUNCIL, FOOTPATHS AT TOWNHILL PARK PUBLIC PATH DIVERSION ORDER (1/22) 2022

This Order is made by Southampton City Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the Owner of the Land crossed by the two footpaths described in paragraph 1 of this Order it is expedient that the line of the two footpaths should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Southampton City Council definitive map and statement require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER

- The two public rights of way over the land situate at Townhill Park and shown by a bold continuous line on the Map contained in this Order and described in Schedule 1 to this Order shall be stopped up after 7 days from date of confirmation of this Order and thereupon the Southampton City Council definitive Map and Statement shall be modified accordingly.
- 2. There shall be at the end of 7 days from the date of confirmation of this Order a public footpath over the land situate at Townhill Park described in Schedule 2 to this Order and shown by a bold broken line on the Map contained in this Order and thereupon the Southampton City Council definitive Map and Statement shall be modified accordingly.


SCHEDULE 1
