

## Quarter 1 Report for 2025 - 2026

# What has the Tenant Participation and Engagement Team done in the first quarter of 2025/26?

Welcome to our first quarterly report in this financial year, summarising engagement activities from the 1<sup>st</sup> of April to 30 June 2025.

We were busy this quarter again - meeting tenants from social housing providers in South-East England, delivering relevant training to tenants, finalising Anti-social behaviour (ASB) report and attending the regional TPAS event.

## **South Coast Training**

#### Bringing tenants together from the South Coast region for an informative and interactive day of training and networking

The South Coast Training Group started in 1999 - the group has gained momentum, and we now have 9 different housing providers across the South that come together for South Coast Training. Up to six tenants from each organisation attend for a day of training and networking with tenants from other organisations.

In April 2025 five tenants from Southampton attended the training on understanding Performance Information / Behavioural Insights and Resident Involvement & Engagement Standards – the training gave tenants new skills and knowledge to question how the services are delivered and to what standard.



Here is what John said about the day:

"I found on balance, the 'South Coast' training, the day was very informative, good peer/ resident participation again with good examples put forward to enable understanding of various situations from both Housing Authorities and Associations. The event allowed me to network with other residents/my peers on some common issues and was excellent."

# **TPAS** regional, Southern **Members** event

On the 17 June, the Tenant Engagement Team took a group of tenants to a special regional conference in Winchester organised by the Tenant Participation Advisory Service (TPAS).

Our team of 13 tenants and staff picked up lots of useful tips. There was also interesting presentations from the Regulator of Social Housing with a good opportunity to ask questions (especially following our recent C3 rating) and also the national Stop Social Housing Stigma campaign.

Particularly useful was the opportunity to talk to and learn from the tenants and engagement staff from all the other landlords who were there too.

Here is what Ann said about the day: "I had a great time met lots of different people, really interesting gathering and lots of new experiences..."; Kathleen joined her in the praise: "I found the conference really enjoyable. I was taking to ladies on a different table and the work one lady did was really helpful and so thoughtful for a gentleman from a different council or landlord. Another gentleman telling us about stigma was really good also," Anna added: "Conference was interesting, and I am very grateful to be a part of it." Lynda said that she enjoyed learning new things on this day but also being updated.

I am certain that I've heard a little song at the back of the mini bus on the way home too....

All in all, it was a really interesting day. With special thanks to <u>CVM Group</u> who donated their new <u>minibus</u> for transportation enabling us to get to the event.

## **Building Safety Group**

# The Building Safety Group needs more members from the high-rise blocks

<u>The group</u> is made up of representatives from different tenant engagement panels. It helps to influence and challenge health and safety policies and practices.

The group members now receive all the key building safety performance information, so that they can question the building safety; for instance, they just probed the repairs work: the trades rubbish is sometimes left behind after the repairs were completed –raising potential fire safety concerns. The building safety officers will now discuss the process and recommend changes to ensure safety of the residents.

The group is planning a visit to Redbridge Fire Station soon to learn more about building fire safety.

## **Supported Housing Forum**

#### **Busy time for Supported Housing**



It's been an important time for the Forum. You are probably aware of the council consultation looking at changes to the Supported Housing service and associated charging. In April they held a special meeting with the Director of Housing plus the Cabinet member for Adult Social Care and others to make sure that decision makers were hearing direct from tenants about the impact of the changes. For the May meeting they heard the results from the consultation and await to hear the final recommendations.

But that's, not all. The Forum also hosted an extra packed meeting giving residents the chance to feed into the Government Consultation looking at creating new standards for Supported Housing across the country. Michael and Ali Khobzi, Service Development Manager, went through the proposals with the group and Ray the Chairperson completed a consultation response on behalf of the group.

## Residents Help Shape our Sheltered Housing Service

How you made the difference....

We're excited to share just how much of a difference your involvement has made in shaping our redesign of older persons accommodation (Sheltered Housing Service). By working closely together, we've made sure your ideas and feedback are at the very heart of our plans.

A dedicated working group of eight residents from the Sheltered Housing Forum joined forces with our staff to redesign the service and make sure it reflects resident's needs. The redesign consultation included online surveys, friendly meetings at lots of schemes, and personal invitations sent to every resident—plus extra help from our team for anyone who wanted one-to-one support.

Ray White, Chair of the Supported Housing Forum, played a huge part in the process by co-presenting at every consultation Drop-In session. This meant there was always a resident's voice centre-stage, and it gave everyone a chance to chat with Ray and share their thoughts directly. Your comments and suggestions made a real impact and helped steer our project in the right direction. Our proposals mean lots of residents will have more choice and control and be able to opt in and out of services.

Ray also got involved in choosing our new telecare contractor (warden call system), bringing your perspectives right into the selection process. His feedback helped us pick a contractor who really understands what matters most to you.

Working together in this way has not only shaped the service but it's also built stronger relationships and a wonderful sense of shared ownership. Hearing from you early and often has given us new ideas, confirmed we're on the right track, and made sure everyone feels part of what we're doing.

A huge thank you to all residents who took part and shared their thoughts. We're thrilled with what we've achieved together so far, and we can't wait to continue building on this success. Rest assured, you'll always be at the heart of everything we do!

The project began with me presenting a pitch to the Film & Television students, with the hope that it would be selected for development in the following weeks. I was delighted when my pitch was chosen by Spencer, Rob, Will, Steph, and Max, who formed the production team. Working with them has been an excellent experience — they were professional, approachable, and demonstrated a clear understanding of the brief. The final film exceeded my expectations.

Beyond their technical skills, I was particularly impressed by the team's interpersonal approach. They engaged respectfully and patiently with both adults and young participants during filming, showing great sensitivity to those who were new to being on camera.

#### 2<sup>nd</sup> May Volunteers Awards Ceremony

Had a great evening at the Volunteers presentation evening in the Mayors Chambers at the Civic. This is a celebration and thank



you to volunteers in the city that give up at least 100 hours a year of their own time to support charities or others. I put forward Debbie Hendry and Chris. Debbie volunteers for Junior Wardens and multiple other charities and organisations across the city. Well done Debbie for your award and thank you for continuing to support the Junior Wardens and the Intergen program.

#### **Townhill Park Art Project**

The Junior Wardens supported an Art Project in Townhill Park over the past few months.

I have supported this project from the start, ordering all of the materials, cutting all of the art boards & priming them before distributing them to the school. I collected the finished boards and then installed them on the hoarding after painting out the graffiti with a treeline design.

The 1<sup>st</sup> part of the project culminated with the school children showing off their artwork to parents, the groups involved in the project, Local MP Darren Paffey and Cllr Amanda Barnes-Andrews.

I was really happy to receive a really nice email from one of the community leads, saying thank you for all the support and a beautiful hand-made card from the school children.

Hi Ian,

A heartfelt thank you for your outstanding work on the Townhill Park Art Gallery project, launched last week. While it was a team effort, your creativity and dedication were absolutely essential in making it happen.

Townhill Park has long struggled with the negative visual impact of extensive hoarding boards, especially those on Benhams Road, which children

pass daily on their way to school. These boards had become a source of concern, particularly when covered in graffiti that some children began mimicking in their schoolwork. Transforming these spaces into a positive, inspiring environment was incredibly important.

Thanks to funding from the Land Release Fund—available only for materials—you stepped in at a crucial time. You identified the required art supplies, handled the purchasing and logistics, and managed the production and delivery of over 80 art boards to the school and community.

Your efforts enabled a wide community partnership—including the school, home education groups, local hubs, and community organisations—to engage residents in painting the boards. The resulting artwork has brought real pride and positivity to the area.

You also took the lead in installing the boards, including cleaning up existing graffiti. The launch event on 27th June was a great success and very well received by the local community. MP Darren Paffey was there to congratulate the children's work and thank all those involved with the project.

With a second phase underway—including new artworks by both children and adults—we're looking forward to your support again for the next installation at the Rowlands Walk site in August.

We have engaged with 1576 tenants in Quarter 1 of this financial year.

Please note – we have now started collecting the tenant engagement figures from other housing departments, so the figures are higher than in the previous financial year.

For the purpose of this report, tenant engagement means involved tenants, leaseholders and shared owners living in council properties, who got involved in shaping and improving our services using variety of methods available: from attending meetings and events in their local area, tenant's association meetings, formal panel meeting to email consultation and focus groups.


The figure does not include any emails sent to our engaged tenants for the purpose of sharing useful information.

Below we can see the consultation figures: we are committed to consulting tenants, leaseholders and other stakeholders on matters that affect them.

The consultations are a specific type on engagement with tenants - they are acts of discussing specific issues with tenants/groups before making a decision about it.

We are now collecting the consultation figures from other housing departments; but please note – it is still a work in progress.



#### Panel's recommendations

Tenant panels and forums challenge the performance of us as the landlord, hold us to account and suggest improvements. They choose subjects to review, conduct inquiries and recommend changes and improvements. The results are then reported back to the senior managers.

We are happy to report that all the recommendations proposed by tenants were accepted, the implementation pending – read our next report for the update on recommendations.

## Housing social media

Housing Service have 1986 followers, an increase of 190 in one quarter! We had exceptionally high Facebook "traffic" in the first quarter with 142,300 views as we had a few posts on apprenticeships that draw lots of attention – we will make sure to get more posts on apprenticeships in the future.

This group currently has 145 members - up from 136 in the last quarter.

Junior Neighbourhood Wardens' Facebook page got 861 followers (up from 746 followers in the last quarter).

I hope you have found these quarterly reports interesting. It shows how we engage with tenants every quarter and try to improve housing service.
